## SPRING SALE OF LUING BREEDING STOCK DINGWALL AUCTION MART

**WEDNESDAY 18<sup>TH</sup> MAY 2022**

1. All bulls must be inspected prior to the sale. Bulls will then be weighed and measured in the market and must measure a minimum of 52 inches at the shoulder on the day of the sale with a minimum scrotal circumference of 38cms.
2. **Every consigning herd must be a member of a CHcS accredited health scheme and all stock must be vaccinated against BVD (vaccination details to be included with the entry form). If herds are not accredited free of BVD, then sale animals must be tested virus negative (test results to accompany entry form).**
3. Pedigree and Appendix A Luing heifers are eligible for entry. Older pedigree stock in good condition may be sold at the end of the main sale.
4. The order of the sale will be: In-Calf Heifers (class 1); Bulling Heifers (class 2); Yearling Heifers (Class 3); Cows (in-calf and/or at foot - class 4); Bulls (Class 5);
5. Bulls must be available for inspection by **8am** on the morning of the sale. Any animal that fails inspection cannot be sold in the sale and must be removed from the sale pens. All females must be numbered and available for inspection by the Fieldsman, by 09.30hrs on the morning of the sale. **Any animal with a black nose or displaying unruly temperament will be rejected.**
6. Bulls will be catalogued and sold in descending age order.
7. Heifers will be sold in lots of any number, starting with in-calf heifers (or with calf at foot). Each owner's entries will be sold in one draw unless they number more than 20 in total.
8. Official UK tag numbers must be given on the entry form, relevant to all animals entered in the sale and the onus is on the vendor to ensure that each animal is correctly double tagged before entering the market / when presented for inspection.
9. All animals presented in the ring are expected to be clean and groomed, as befitting a Pedigree Sale.
10. All animals will be sold under the terms and conditions contained in the NBA breeding warranty, which can be found at <https://luingcattlesociety.co.uk/wp-content/uploads/2021/02/NBA-Terms-and-Conditions-of-Sale.pdf>. All vendors and purchasers should be familiar with these terms.
11. A commission of 5.75% shall be paid. (3.75% to auctioneers, 2% to the Luing Cattle Society).
12. Bracket together animals that you wish to be sold in the ring as a group.
13. In the case of in-calf heifers, please give due date and service sire.
14. Include any information about health schemes/status that you wish printed in the catalogue on the **Health Declaration Form** (must be supplied with entry forms).
15. Vendors are encouraged to display Health Cards at the sale, and these need to be applied for directly with your health scheme provider.
